



CALL FOR PROPOSALS: SUPPLEMENTAL INFORMATION

An Impact Evaluation of the EduApp4Syria Prize Competition Digital Game Apps

Released by: Digital Learning for Development (DL4D)
and All Children Reading: A Grand Challenge for Development (ACR GCD)
Opening Date: 30 January 2017

1. The deadline for submission of full proposals has been extended to 5:00 PM, 3 April 2017 UTC/GMT +8 (Philippine time).
2. Eligibilities: Individuals or institutions applying for this award must currently be working with Syrian refugees in either Turkey or Jordan, or have a partner institution that meets this criterion.
3. The open beta versions of the two EduApp4Syria Prize Competition winners, **Antura** and the **Letters** and **Feed the Monster**, will be available for download on Google Play and the App Store by 20 March 2017. 4. Sampling: Applicants are expected to propose a sampling design for the randomized controlled trials. Applicants can assume an alpha level of .05, power level of .80, and expected effects sizes of 0.5 for treatment group vs. control group and of 0.2 between treatment groups. General sample size requirements across all EGRA subtests would likely range between 228 to 234 (76 to 78 each for the two treatment groups – one per winning app – and the control group) based on the above expected effect sizes. However, applicants should justify their proposed sample size.
5. Dosage: Applicants are expected to propose the appropriate trial dosages for each of the winning apps. It is recommended that trial subjects be asked to play a game for not more than one hour per day.
